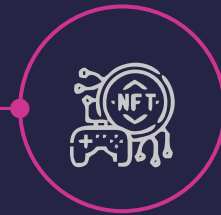

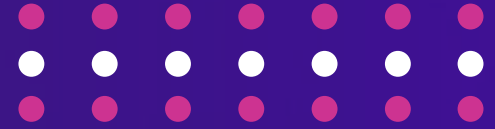

## Gaming revolution – moving into the cloud

Gaming is moving into the cloud, following video, music and other services. For gamers, cloud gaming is 10x cheaper than owning personal gaming hardware (PC/console), leveraging share economy principles. • The development of GPUs, the Internet, and low-latency streaming have diminished the demand for personal gaming hardware. In fact, the next generation of consoles could be the last one that is based on hardware.

Moving gaming into cloud technology has now become inevitable – 70% of Steam players are unable to play AAA titles like GTA V in high resolution, and 30% of players cannot even run such titles on their obsolete Pcs.

The demand for cloud gaming will continue to grow. The demand for latest generation hardware, and the increased requirements from gaming caused by resource-intensive VR technologies, will be making home hardware more and more expensive and non-viable for casual gamers.

Digital advertising spend worldwide (outside of China) was \$325B in 2019 and is on track to reach \$389B in 2021. By 2024, advertising spend will be over \$525B. \$525B is the addressable market.

As much as 40% (\$160B) of the ad spend is stolen by ad fraud. IGC Gaming Entertainment will rectify this problem. IGC Gaming Entertainment has a key patent in video monetization with Proof of View and can tap into not only the ad market but the broader consumer market through NFT digital collectibles, another quickly growing market. Proof of View also provides authentication of several parameters including chain of ownership. PoV is not limited to views but can be also used to verify any digital image viewer.

Approximately \$250M of cumulative sales of NFTs have taken place in the last 12 months while NFTs market cap growth has exceeded 1,785% in 2021 as demand explodes.

### The Problem IGC Gaming Entertainment is trying to solve

Out of some \$400 Billion of online ads, as many as 40% or approximately \$160 Billion worth are seen by bots and not humans. That's \$160 Billion of wasted advertising spend by brands!

There are over 2 million video publishers struggling with the problem that brands don't want to pay much for their ad space because they just don't believe that humans watch the ads. Even Google and Facebook must return substantial amounts of money to brands every quarter, because ad fraud companies that detect fraud, after the event, are used by brands to justify clawing back their ad spend. And of course, that adversely affects the content providers of YouTube and other platforms because they get much less money.

Brands pay 5 to 10 times more if they are convinced that the fraud levels are low. And this is where IGC Gaming Entertainment comes in. IGC Gaming Entertainment has recently received the Canada patent to its Proof of View technology that detects and eliminates ad fraud and only records, on the Tron smart chain, genuine human views of ads and video content.

IGC Gaming Entertainment will inform the community from time to time after buy back and burn events.

## IDO and NFT Marketplace

The IGC platform will be developing a Non-Fungible Token (NFT) ecosystem in the product roadmap, which will include a consumer-friendly NFT marketplace with an in-built digital wallet, allowing users to effortlessly purchase NFT. Developer tools will be available in the IGC ecosystem for users to issue their NFTs.

### What are NFT's ?

Non-fungible tokens, or NFTs, are cryptographic assets on the block chain that include unique identification codes and metadata that separate them from one another. This is in contrast to fungible tokens, such as crypto-currencies, which are identical to one another and can thus be used interchangeably as a form of transaction. Since the Cryptokitties craze, the market for NFT has risen at an exponential rate, rising from around USD\$210 million in 2019 to a projected USD\$710 million this year in 2021!

## AMM and DEX Platform

IGC is a smart contract system on the Tron Block Chain that uses an automatic liquidity protocol powered by a constant product formula. It does away with the necessity for trusted middlemen, placing a premium on decentralization, censorship resistance, and security. Automated Market Makers have changed the way people trade crypto. IGC also allows users to directly swap tokens with each other. Built on Tron Block Chain, users can trade TRC-20 tokens

### Staking and yield farming

Users can earn IGC while also supporting IGC by staking LP Tokens on Yield Farms.

Staking or lending crypto assets in order to create high returns or rewards in the form of additional crypto currency is known as yield farming. Thanks to new breakthroughs like liquidity mining, this inventive yet dangerous and unpredictable application of decentralized finance (DeFi) has exploded in popularity recently. Yield farming is currently the most important development driver in the still developing DeFi sector, helping it to grow from \$500 million in market capitalization to \$20 billion by 2021.

Yield farming techniques, in brief, encourage liquidity providers (LPs) to stake or lock up their crypto assets in a smart contract-based liquidity pool. Buyers can also purchase IGC tokens using their wallet on a cryptocurrency site. Then set them aside for a bit to collect profits and earnings from the interest payments made to the token holders.

It can be stated that the crypto industry repeats the history of the stock market: it's enough to recall how at one time the shares of current business giants – such as Alibaba or Facebook – were sold as part of an initial public offering (IPO) on the American stock exchange Nasdaq, specializing in high-tech companies.

The cryptocurrency community seems to have decided to take the already beaten path, and IGC Token readily joins the global trend. It is necessary to take into account that in order to enter the IEO on top exchanges, startups need not only huge amounts of funds that are too heavy for the beginning, but, as a rule, well-established business contacts with representatives of the top management of these exchanges. In contrast, IGC Token offers cryptocurrency blockchain projects to attract funding according to well-defined and common rules and standards that will be developed by experienced advisors with many years of relevant industry experience.

# Market Pain Points

## Closed Loop gaming platforms with illiquid assets

Gaming companies hold in-game assets on their own centralised servers to prevent illegal duplication and cheating. If a player owns a sword, gun, or car in a game, the digital asset was in their account. However, this asset sits on the servers of the specific game's publisher or developer, trading within the publisher's marketplace's rules and regulations. This greatly presents an obstacle for players who wish to trade assets outside of games, a practice that was normalized since the release of World of Warcraft. Without the ownership of their virtual assets outside of the game, players are forced to use unconventional markets and trade hubs, with no safeguards and guarantees, exposing themselves to fraud and cybercrime.

## Lack of monetary incentives for community contributors

With the rise of connectivity, there is an increasing number of users who are devoting a significant amount of time and energy contributing to the online community. Many often, they are given recognition through non-monetary means such as ranking and badges with the monetary benefits going to the game providers.

IGC Token believes this model can be changed to distribute value across the entire system, aspiring towards an active, fair, and transparent gaming community.

## Low ROI for smaller game developers

Small-scale game studios which have innovative ideas and strong creative teams often lack operational effectiveness. Their focus on their core business of game development leads to dependencies on external service providers. This often comes with a hefty price tag. Today, developers pay an inordinate amount of the revenue just to distribute their games, let alone market them. For example, gaming developers pay 15-30% of profits to Google Play and Apple's App Store. In extreme cases, like China, developers who want nationwide distribution pay anywhere from 20-80% of their revenue. Furthermore, now that mobile games are mostly free-to-play, small developers are left with very little revenue to do any additional marketing, to pay their normal overhead, invest in new IP, and are becoming less able to recoup the requisite development costs and stay profitable.

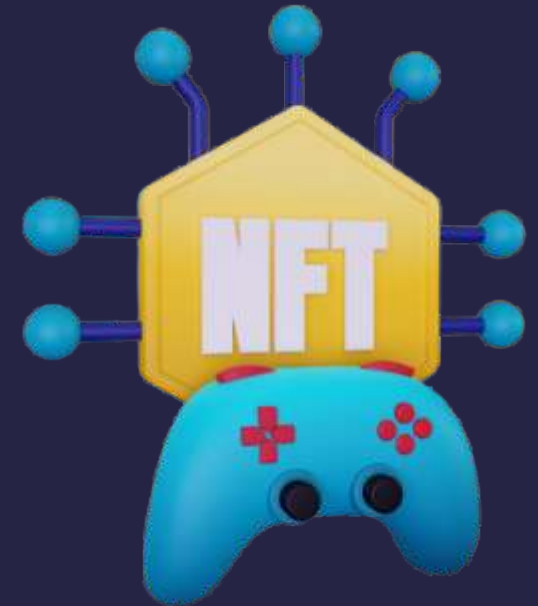
## Game Overview

Moreover, we designed the game in a way to make it “live forever” with a narrative that never becomes boring.





# Commercial Inspiration

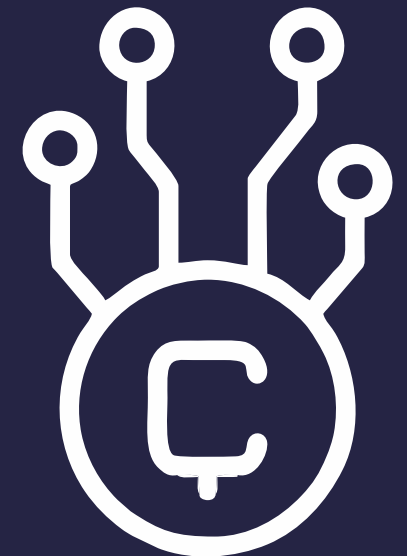
## Goals

Given the data from inspiration games mentioned, the unique attractive graphic style, and the novel ideas we add from blockchain thinking, and PR-friendly and user friendly governance model, we set these goals:

### Millions of users

With the unique style and large interest in these kinds of games, as well as the unique element we bring, we think the game can compete in the market and share similar numbers as the other games, reaching millions of users. Mainly, as no previous experience or interest in blockchain or cryptocurrencies is required, we aim at fully developing the potential of blockchain economy, while abstracting its complexity from the users.

Antler Interactive has with their previous games Krystopia (1 and 2) sold around half a million copies, and sales are still increasing, so we do have some experience already to launch games that have potential in millions of users



## Key Game Features

### Sandy Coast

Made famous by local celebrities like Dr. Hilton, Sandy Coast resembles the Maldives. As the name suggests, the Sandy Coast is mostly composed of sand and includes multiple islands. This is the obvious destination for any beach dweller. Fancy a life on the beach, then this is the place for you!

### Submerged Islands

The rich waters of the Submerged Islands are stalked by seafaring pirates, seeking the treasures and mysteries beneath the waves – or hunting those brave enough to try and get there first! Think shipwrecks, chests and driftwood. Something for the more adventurous minded perhaps? Ahoy there neighbor!

### Avatars

Each player is represented by an avatar in the game, and players could interact with others through the avatar. Players could also modify the avatar by installing different assets to it.

### In-game asset

There are in-game assets that can be deployed into the game and they can be bought on the marketplace. Among them - houses, animals, veggies, decorations or cosmetic items for the player's avatar. In addition, platform users can create assets using the NFT creator and monetize their design skills! DeFi capabilities will be added to the in-game assets.

### Progression system

IGC Token will have a dynamic progression system that rewards players as good citizens. Players will progress through the game by completing fun quests, favours and other activities.

### Shared Quests and Community events

One of our key values in the game is to create the atmosphere of friendship and common interests. The ultimate purpose in IGC Token is to create an alternative beautiful world where anyone can play, find friends and work together. Thus, IGC Token will enable various possibilities for players to work on a shared goal and join resources to complete fun activities. The game will also have community-created events where players will be able to create and participate in activities



## Blockchain Features

IGC token is the native currency in the game, as well as mirrored as an TRC 20 token. It allows token holders to play, invest and also be part of the game. There is a fixed supply of IGC tokens.

There are several utilities of the token.:

**In-game currency:** IGC could be used in the marketplace for purchasing assets and also special skill sets in the game (e.g. Fertilizers)

**User designed revenue models:** for land and assets in the game, owners could design rentals and visitor fees features. For example, users could charge for players that want to visit the museum on the island;

**Special game content (DLC):** certain quests and special features (opening a store) are only available to IGC holders that stake the tokens for a fixed amount of time

**Social feature:** send IGC tokens in the chats with neighbours; present assets to visitors; exchange NFT assets;

**Play to earn:** to encourage players to contribute to the game and to maintain traction, there will be experience points awarded for quests completed. Those could be exchanged into in-game assets that could be transacted.





# Game Assets

## Collectibles and scarcity

In gaming, the element of scarcity and collectible items have been around since even before computers. Also in IGC Token, there will be limited editions, scarce items. In addition to items designed by the game developers, there will be user-generated content.

The openness of block chain provides information about how many items exist in total, how large is a limited edition, etc. The additional openness of IGC Token's novel "decentralized assets" explained below improves on this further, as you can openly inspect similarity of items.

## Scarcity in IGC Token exists on different levels:

- Fixed supply of land
- Limited editions of items
- Scarcity limits of user-generated content. Users acquire rights to generate items, these rights stipulate the max number of copies, thus enforcing scarcity requirements





# Fully Decentralized Assets

In mainstream blockchain games, NFT consists of a small amount of binary data that represents ownership of an asset. But there are many more elements needed to actually having full control of an asset:

## How it looks

Non-physical characteristics (strength of a sword, speed of a car)

Game logic implementing the asset: Swinging a sword, driving a car

So far, in most blockchain games, this information is often stored elsewhere, not under the control of the player and instead under the full control of the game company. In My Neighbor

IGC, we strive to improve on this as much as possible. So far blockchain games have been an emperor without clothes, we aim to dress him up with something cute.

IGC Token stores much more data about items on-chain, using the Chromia originals protocol, a standard for asset definitions. Also, the logic of items will be defined in a free/libre/open-source game, running on-chain and being under the ultimate control of the players, see the chapter on Community Council DAO.

## Marketplaces and trading

One advantage of decentralized ownership is that they can be traded on marketplaces outside of the game companies' influence. This can increase financial incentives for gamers to purchase and create items in the game. Naturally, this feature will be available with IGC Token. Items can be traded in several marketplaces:

### In-game marketplace

A great casual experience in the graphic style of IGC Token. We believe this will be the first choice for a vast majority of the players, most of them come for the game itself more than for the blockchain elements, and they might not even know the difference. Note that this marketplace will also be blockchain based and ownership be with the players.



## External marketplaces on Chromia

Items can also be read by the Chromia-developed marketplace. Chromia Market allows you to search for items based on data about assets, such as color and item-category. This is due to the fact that more data about assets are stored directly on the blockchain compared to many other blockchains.

# Fully Decentralized Assets

## Marketplace on Steam

IGC Token will use the existing game platforms, such as Steam, to sell items, in particular first hand items collections and in-game currencies. This is important for onboarding of noncryptocurrency users. We believe that we have a strategy to make this comply with the terms of service.

## A game controlled by players

Imagine a game that can not be shut down, lives forever, where players control the project. A new way to implement games, challenging old models of doing business.

IGC Token will push the boundaries of blockchain gaming by letting the users control the game and development. A public democratic application, with formal control by players and other stakeholders such as investors.

## Community Council, or DAO

IGC Token will be a decentralized organization called Community Council, a digital democracy and mini-universe. This could not have been possible without blockchain, since we now can implement rules that govern what source code is running. This is an embodiment of the Chromia vision of public applications.

## Free and open source

The source code will have an open source license so users can control and ultimately fork the application. Note that this game depends on Unity, which is a non-free platform.

## Logic on-chain

The running game will be on the blockchain, as much as possible, thus avoiding the situation where a single entity controls the server.



# Technology

## Game Core

### Backend: Chromia

The first layer to this project is the game backend infrastructure. The project was created on the fundamental idea that it will operate exclusively on the Chromia platform, with a few exceptions mentioned in this document.

The backend is a chromia relational blockchain database that is used in conjunction with Unity to operate accounts, token transfers, relational data and user progress, among many other things. It's meant to follow the development of cross chain playability and interaction with NFT:s.

The unique database aspects of chromia gives the ability to do complex backend logic directly on the blockchain without spending much development time.

### Frontend: Unity

The third area in the project is the economic infrastructure. "Property/Plot" auctioning, asset trading, token transactions.

### Backend: Chromia

Gaming, marketplace and auction logic is done on the Chromia blockchain

Frontend: Web and Unity The frontend to marketplaces and auctions can be done as a web application embedded into the game. Parts of the UX might also be done directly in Unity.





# Technology

## Integrations: TRC20 and Steam

The IGC token will be transferable between TRC20 and native Chromia token.

This bridge is developed by Chromia outside of this project. The Steam marketplace and sales there will have an integration code connecting to Chromia..

## Governance DAO

This project will not only create a game, but code for a decentralized autonomous organisation called Community Council. The DAO implementation should be handed out to an external company, we identified Chroma Way as the initial partner.

## Backend: Chromia

Voting and rules of governance can be implemented in Chromia. Being a relational database, this is comparatively easier than with other blockchains.

## Frontend:

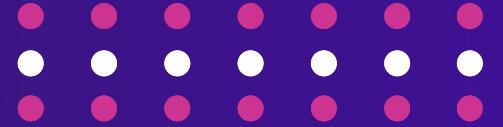
Web The DAO interface will be a web application, outside of the IGC Token game.

Chromunity is also used by other projects such as the Hedget11 DeFI application. By integrating the Chromunity open source code, developing the Community Council (DAO) will be easier.

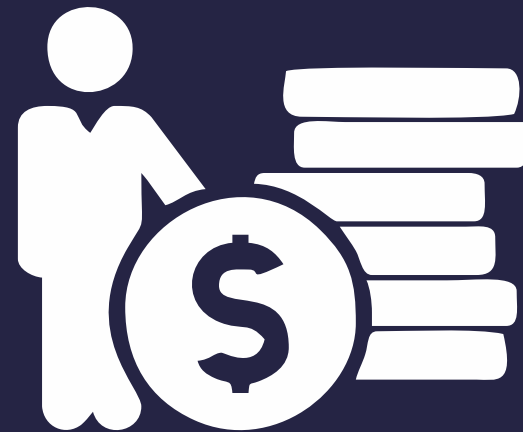




## Token Economics
